



He was a Lecturer in the Department of Politics and Public Administration of Peking University (1988-1990); Research Fellow and Senior Research Fellow of the East Asian Institute, National University of Singapore (1997-2005); Professor and Research Director of the China Policy Institute, University of Nottingham (2005-2008); Professor and Director of the East Asian Institute, National University of Singapore (2008-2020). He was a Fellow of the US Social Science Research Council-MacArthur Foundation (1995-1997) and a John D. and Catherine T. MacArthur Foundation Research Foundation Fellow (1998-2000).

Professor Zheng's main research interests are international relations, foreign policy, Sino-US relations, China's domestic transformation and its external relations. He has authored and edited some one hundred books, including ten English monographs. He has published numerous research papers in international academic journals.



Social science theory distills social experience and practice, and the existing social science system has its roots in Western history and practice. A truncated application of Western theories does not wholly and objectively reflect China's history and practice but rather creates ideological confusion. The lack of theoretical tools to understand Chinese society makes it difficult to construct a body of knowledge based on Chinese experience, which is urgently needed to understand China. Only a corrected perspective can lead to programmes, rules, and policies truly appropriate for China. Building a body of knowledge in the social sciences in China from actual Chinese practice and historical experience is at the heart of the IIA's mission.

Background

The Chinese University of Hong Kong, Shenzhen Education Foundation is a Shenzhen "5A" grade foundation established in 2014. The purpose of the Foundation is to provide financial support for the study and living expenses of college students; improve the quality of college education and the scientific research conditions; broaden and enhance sources of support for the University's advancement.

Introduction

The Global and Contemporary China Research Fund (referred to as the Fund below) aims to provide effective support for the long-term and sustainable development of The Institute for International Affairs, Qianhai of the Chinese University of Hong Kong, Shenzhen. Drawing on the experience of domestic and foreign think-tanks, the Fund aims to create a powerful talent pool through wide support and sponsorship from enterprises and society. The Fund will provide objective, independent, visionary and strategic policy research, industry analysis and forecasting based on trend analysis in domestic and international affairs. Our Mission



Introduction

To attract young talented people with cross-disciplinary background to be devoted to public policy research, The Institute for International Affairs (IIA) of The Chinese University of Hong Kong, Shenzhen (hereinafter referred to as "the Institute") provides the IIA Scholarship to support the qualified PhD candidates of CUHK-Shenzhen.

The candidates who have successfully gained the IIA scholarship will be entitled as "IIA Fellow".

Who can apply	Candidates who have received an unconditional offer from The Chinese University of Hong Kong, Shenzhen, and have decided to pursue a PhD degree at the University. (Those who have received full funding from other programs are not eligible for this funding)	
Туре	Full scholarship, half scholarship and stipend. (The type of funding will be determined based on a comprehensive evaluation by the committee)	
Duration of scholarship	Normally 3 years, no more than 4 years, paid in installments by semester or academic year.	
Other requirements	IIA Scholarship recipients shall provide research-related services to the Institute for the duration of the grant. Detailed responsibilities will be stated on the IIA Scholarship Agreement between the Institute and recipient.	

Application Process

The applicant shall go through the process of a) online application; b) preliminary screening by the Institute; c) interview by the IIA committee. The applicant should carefully read the scholarship handbook of the year published by the Institute, and submit all the materials that are required. The applicant shall be responsible for the authenticity of the materials.

The Institute will inform the candidates who have passed the preliminary screening for an interview by the IIA committee. The final results will be sent to the candidate's program director for approval first, and then to the IIA Director for final approval. Candidate who has passed all the process will sign a formal agreement with the Institute.
